RIVERBOATS UP IN FLAMES

From the Whitehorse STAR, Friday, June 21, 1974

Hundreds of people stood on the banks of the Yukon River yesterday morning and cried as the riverboats CASCA and WHITE-HORSE were engulfed by flames.

The two grand old ladies of the White Pass and Yukon Route fleet caught fire at approximately 10 a.m. and were reduced to two large heaps of ashes less than two hours later. The dry wooden ships burned like tinder, with flames rising more than 100 feet in the air within minutes and giving off an intense heat.

Fire officials still have found no cause of the fire. and say that investigations are continuing. Firemen were still hosing down the red-hot coals late yesterday, and no inspection was expected for at least 24 hours, according to Yukon fire marshal Tom Shortly after the fire call

went out, police helped three young people off the CASCA. The trio, in their early twenties and from Ontario, had been living on the boat for a week. They were taken in to custody and questioned by police until late Thursday afternoon before being released. No charges were laid and police, along with fire officials, are seeking another explanation for the

The blaze began on the

CASCA, spreading rapidly to the WHITEHORSE, less than 10 feet away, and threatened to engulf a storage shed owned by White Pass as well. Firemen, after overcoming initial difficulties with a lack of water, managed to douse the shed and prevent the fire from going beyond the bounds of the riverboats. The pair of stately old steamboats were two of five left from a fleet that plied the rivers of the Yukon during the first half of this century. The WHITEHORSE, built in 1901, was the acknowledged Queen of that fleet. Ironically, she was built on the very spot that she finally died on yesterday.

The three remaining members of the White

fleet are Pass KLONDIKE, situated in town just up the river from the two that burned yesterday; the TUTSHI, settled in Carcross; and the KENO, now a national historic site at Dawson.

Within minutes of the fire alarm, hundreds of people had gathered at the final resting place of the two old sternwheelers. Dozens of old-timers who were here when the boats were actually in operation recalled memories to quiet bystanders.

Roy Minter, an employee of White Pass who had long lobbied for the preservation and restoration of the neglected boats, was at the scene too, looking slouch-shouldered and defeated.

"...I've always thought of Dawson as the center of the Gold Rush" he said sadly, "and of Whitehorse as the center of transportation during those days. These boats were such an integral part of all that. Today they're gone and the Yukon just lost a little of its soul."

MARTHA BENJAMIN CANADIAN CHAMP

"Martha beats them all" a STAR headline proclaimed in 1963 when an Old Crow skier and mother of five children became the first Yukoner to win a national skiing title

Twenty-five year old Martha Benjamin won the senior women's cross country skiing title at the Canadian championships in Midland, Ontario. Her time over the 10 kilometre race was 43.29 minutes. And in 1989, 26 years after that historic event, Benjamin was inducted in the Yukon Sports Hall of Fame. "After all these years, I didn't expect to receive something like this," she said. "I just had it in me that I wanted to do it, and I did it," she said of her win in Midland Ontario.

Benjamin and Ben Charlie were the only two skiers to attend the championships. Charlie ranked 11th in a field of 48. His toughest competition came from a group of Finns from Sudbury who swept the field.

Both skiers brought high credit and distinction (not to mention the publicity) to their community and to the Yukon as a whole. Star correspondent Edith Josie wrote before they left: "I had wire from Mr. Harry at Whitehorse. He said Ben Charlie and Mrs. Martha Benjamin will go to Ottawa for International Olympic Competition for skiers on February 13. Frank Cook will take them out. Everyone is very glad to hear these two will go out long travel. Hope they had good trip. Old Crow is little town and Father Mouchet is training boys and girls for the skiers. Now they even go way out to Ottawa. Sure big surprise for the people in Old Crow.

Mouchet, an experienced ski instructor for the French army, designed a training program which is now called TEST (Territorial Experimental Ski Training). This program strives to stimulate and motivate children to discover themselves, develop self-reliance through a rigorous training schedule and gain self-confidence through a series of tough, but surmountable challenges.



WHITEHORSE SWEPT BY FIRE

Whitehorse was swept by fire early this morning and is now a mass of blackened smoking ruins. Loss \$300,000.

The single fire engine at a critical moment gave out, and quickly the best part of the city became involved in ruin.

The fire takes the city, extending from the post office to the telegraph office and crossing the tracks, sweeping the railroad, the White Pass depot, three of the best hotels and dozens of the smaller buildings.

1962 News from the Whitehorse Star

Kuzma Murder Trial Underway Here

Twenty-eight witnesses were scheduled to be heard in the murder trial of Nicholas Kuzma in connection with the August 18, 1961 death of Canadian Customs man Roy Wilson. Kuzma was arrested in Haines on the 20th.

Because the charge is one of non-capital murder Mr. Justice John Parker told the jurors he wold not confine them during the trial. Kuzma is being defended by Gordon King with Stuart Enderton as crown prosecutor. The trial commenced Tuesday and should end tomor-

Wilson's bruised and bloody body was found lying about fifty feet from the Alaska Highway at mile 1207.3 on the west side of the right-of-way by Customs Officer Clayton Skelton. Wilson was wounded 11 times about the neck and chest, his face was gashed and bruised and his upper right forearm was

Dr. W. R. Buchan yesterday told the court Wilson died from a wound in his heart. His jugular vein was punctured and also his windpipe. Shown a jackhandle which RCMP Cpl. Steve Penteliuk of Haines Junction found near the body, Dr. Buchan agreed a tool of that nature could have caused some of the

Evidence showed that Kuzma and Wilson had been travelling together on the night of August 17. They spent about six hours at the bar of Seaton's Lodge in Alaska at Mile 1235. William Seaton owner of the lodge, testified Wilson had been obnoxious for about two hours of his stay and had used obscene language. At one point Seaton offered to hit Wilson unless he apologized to Mrs. Seaton for a remark made to her. The two men had been at the lodge separately on other occasions but this was their first visit together.

Seaton also described a fight which

took place outside his lodge in the parking area after Wilson and Kuzma had left early in the morning of the 18th. He told the court he had seen Wilson hitting at Kuzma while Kuzma sat in the driver's seat of the car and Wilson stood outside. Then Kuzma got out, knocked Wilson down and placed one knee on him, hitting Wilson several times. After this they drove away together.

RCMP Cpl. James Ballentyne, who is with the identification branch, described the scene where the body was found. He said there were tire marks between the soft shoulder of the road and the beginning of the bush. They crossed the ditch that separated them. The bush was quite dense but appeared to have been trampled upon. Wilson was lying on is back with one arm across his chest. His shirt was open with all but one button missing. He was wearing only one shoe and sock. A black leather shoe was found 30 feet from the body and a sock was found hanging on a nearby bush. A few feet from the body there was an area covered by a "red substance" about one foot in

Cpl. Ballantyne said there were "scrape" indications on the back of Wilson's trousers.

Cpl. N.P. Schiml of the RCMP lab at Regina testified regarding a jack and jack handle mechanism. He said the jackhandle could have made marks that appeared on the mechanism but he could not positively identify them. The jack mechanism had been found in Kuzma's car.

Miss Marlene Pierce from the police lab said she had identified blood on the jack handle but could not identify the

Wilma Lee and Russell Allan, both of whom were at Seaton's on the night in question, testified regarding Wilson's unruly behaviour. Mrs. Lee said Roy

Wilson appeared to be trying to start trouble while Nick Kuzma tried to settle

She saw Kuzma again the next morning at White River Lodge where she was then residing. He appeared to be "more or less in a state of shock."

Traveler Garth Fuller from Iowa recalled seeing a man without a shirt step from a car a few miles North of the Canadian Customs early on the 19th and motion him to stop. Fuller did not stop. Later, as he was leaving the customs office, a man who appeared to be the same person drove up to the office.

Customs Officer Clayton Skelton met Kuzma as Fuller was leaving the border office. Kuzma told him there had been a little trouble at Seaton's. He said Wilson had asked him to speak to Clayton concerning having someone else cover his shift as he would not be back for a day or two.

He claimed Wilson had been making a pass at a girl and the man she was with had become angry. Then, Kuzma told Mr. Skelton, Roy had got mad and refused to return with him.

Later in the day Mr. Skelton drove to Snag where he spoke to Russell Allan. On his return to the customs office at about 6 p.m. he spoke to customs officer Ken Watts and as a result of these conversations, drove along the highway to the vicinity of Mile 1207.3 with a friend, Lilly Ewchuk, looking for car tracks in the ditch. Miss Ewchuk spotted Wilson's body.

Note: Nicholas Kuzma, 37, was sentenced to fourteen years in jail after being found guilty of manslaughter in the death August 18, 1961 of Roy C. Wilson, Canadian Customs official. Mr. Justice John Parker imposed the sen-

1899 News from The Bennett Sun

Can't Count His Money

Such Is the Sad Condition in Which Alexander McDonald Finds Himself

Alexander McDonald, king of the Klondike, not only is not insolvent but has so much money it is almost a hopeless task to compute it. Such is the report brought out by a shrewd business man who left McDonald about fifteen days ago, and is a partner with him in his many enterprises. "The report is not only absurd but is malicious," said this gentleman.

Mr. McDonald went in to Dawson in March and his business affairs were never in better shape. Since then he has purchased five claims on Sulphur Creek at from \$30,000 to \$50,000 each.

He owns a whole or a fractional interest in 79 claims on Sulphur, Bonanza, Eldorado and Dominion creeks, and there isn't one wildcat among them. Every single claim is turning out a profit daily - and instead of borrowing money Mr. McDonald is loaning it. Rates used to be at 10 per cent per month, but any one with good security can get all the money he wants of McDonald at 2 and 3 per cent a month.

The so called story of McDonald's insolvency had not reached Dawson when this gentleman left, and when it does reach there, there will be a great laugh. The idea of a man being broke who does not owe a dollar and whose clean-up for the winter work amounted to \$1,250,000 is something decided-

ly funny. Since he went to Dawson in March McDonald has paid \$100,000 in royalties to the Canadian government, and besides his daily deeds of charity has made a donation of \$30,000 cash to the Catholic church and hospital.

His income is continuous and he does not have to wait for the result of a winter's work in a spring cleanup. Some of his best paying claims are summer diggings and his pack train of mules comes into Dawson regularly once a week loaded down with gold.

The facts are McDonald is so wealthy it is impossible for him or any one else to make a close computation of his holdings. Besides his gold he has large improved holdings in real estate that bring in a splendid income. The person who started the story of his insolvency simply did so to try to injure the credit of one of the richest, best, most generous and highly respected men in all Alaska.

Mr. McDonald's friends in Juneau do not need these assurances, but they are none the less gratifying-Juneau Miner. — *The Bennett Sun, September 2, 1899*

New Kind of Hydraulic

From the Yukon (Dawson) Sun 12th inst: Several sleigh loads of machinery are expected from the outside today, which may be the initiatory step toward the revolutionizing of the mining industry of the north. The consignment is for the N.A.T.&T. Co., and consists of an experimental plant called the Adams hydraulic lift. It will be installed at once at No. 63 below on Bonanza, under the personal supervision of J.H. Adams, its inventor.

The plant was built in San Francisco especially for the Klondike test. The plan of operation is different from the ordinary hydraulic work, and as the name implies it is in the nature of a lift, whereby gravel can be raised into a sluice box from a point many-feet below. Its principle is similar to a centrifugal pump. The apparatus contains two main pipes, one of which by gravity plays on the bed of gravel and forces it upward through another pipe into a sluice box. Mr. Adams in an interview, said:

"The introduction of the invention is merely an experiment, and much difficulty is apprehended in bringing it to a successful basis of operation. The objectionable features in the north are many.

"In the first place where we intend to experiment the lay of the ground prohibits a bedrock flume to carry away the residue from the works. Again, where heretofore the gravity system has been employed the water must be pumped on Bonanza.

"The plants are now successfully operating in all parts of the world. I have opened up propositions in South Africa, South America, Mexico and Korea. In every case the ground has been handled economically and with great profit to the owners.

"If the results from the Bonanza efforts are all that are anticipated, an order for a number of mammoth plants will at once be given, which will be operated in various parts of the Yukon.

"The beneficial results that will, under these circumstances, accrue to the mining industry of the country cannot be estimated. Ground that is now considered absolutely worthless will pay big returns. To the owners of ground that is fairly rich it will men increased profits.

"The general production of the country would be greatly increased in the saving of many millions of dollars which now go to waste by the present system of mining.

"The N.A.T.&T. Co., realizes the vast benefits to be derived if the idea is successful, and on this basis is willing to spend considerable money and time to demonstrate the feasibility of the new invention."
