A GRIM DEATH INDEED

Of all the accidents that can befall a person on a boat surely an explosion and fire is one of the worst. Three tons of black powder exploded on the Columbian's forward deck that fateful September day and the resulting fireball was carried the length of the

ship by a downstream wind. Everyone in the immediate vicinity of the explosion would die, except for passenger Ernest Winstanley. He would be saved by his long underwear.

The Purser, Lionel Cowper had been burned over his entire body. As was the medical custom at the time of the accident, he had been wrapped in an oily blanket and given strychnine pills. In Whitehorse, when it became obvious that he was going to die, massive amounts of "opiates" were administered, but relief lasted only minutes

LIQUOR VOTE SET FOR **JUNE 23**

All Yukon residents, 19 years and up, will be asked to answer this question on Monday, June 23:

"Are you in favour of lowering the legal age for the consumption of alcoholic beverages from 21 years to 19 years of age?"

Commissioner James Smith announced the date and terms of the plebiscite this morning. It is believed to be the first time in Canada that underage voters will have had an opportunity to express their opinions on a question which directly affected them.

There will be no enumeration of voters, and no voters list compiled for the plebiscite, which will be conducted by Federal Returning Officer Harold J. Mac-Donald of Whitehorse. Instead, each voter will swear an affidavit that they are of the full age of 19 and they were ordinarily resident in the Yukon Territory on March 20, 1969. This was the date on which Yukon Territorial Council approved the idea of the plebiscite being held.

THE WHITE DEATH

f all the natural phenomena peculiar to the Rocky mountain region none is more strange, or terrible than the mysterious storm known to the Indians as "the white death". Scientific men have never yet had an opportunity of investigating it, because it comes at the most unexpected times and may keep away from a certain locality for years. Well-read men who have been through it say that it is really a frozen fog. But where the fog comes from is more than anyone can say. This phenomenon occurs most frequently in the northern part of Colorado, in Wyoming, and occasionally in Montana.

About two years ago a party of three women and two men were crossing North Park in a wagon in the month of February. The air was bitterly cold, but dry as a bone and motionless. The sun shone with almost startling brilliancy. As the five people drove along over the crisp snow they did not experience the least cold, but really felt most comfortable, and rather enjoyed the trip. Mountain peaks fifty miles away could be seen as distinctly as the pine trees beside the roadside.

Suddenly one of the women put her hand up to her face and remarked that something had stung her. Then other members of the party did the same thing, although not a sign of an insect could be seen. All marveled greatly at this. A moment later they noticed that the distant mountains were disappearing behind a cloud of mist. Mist in Colorado in February? Surely there must be some mistake. But there was no mistake, because within ten minutes a gentle wind began to blow and the air became filled with fine particles of something that scintillated like diamond dust in the sunshine. Still the people drove on until they came to a cabin where a man signaled them to stop. With his head tied up in a bundle of mufflers, he rushed out and handed the driver a piece of paper on which was written: 'Come into the house quick, or this storm will kill all of you. Don't talk outside here."

Of course no time was lost in getting under cover and putting the horses in the stable. But they were a little too late, for in less than an hour the whole party was sick with violent coughs and fever. Before the next morning one of the women died with all the symptoms of pneumonia. The others were violently ill of it, but managed to pull through after long sickness. - Aisle's Magazine





THE DISCOVERY WELL

Little was it thought when the original "Discovery Well' was drilled in 1928 in the Fort Norman area that, through the exigencies of war, the oil that flowed from there would be piped to Whitehorse, a distance of 595 miles, and refined here. The transportation of men and equipment over a road more than a thousand miles long was one of the major obstacles encountered and overcome. Camps, warehouses and platforms were constructed and pre-fabricated, barges, tugs assembled and Camp Canol was established.

In June 1942 the U.S. Engineer troops arrived in Waterways, a small frontier town northeast of Edmonton, and the men of the navigation system in Norman Wells on the Mackenzie River. By the summer of 1943 the water system had been well established, in the meantime another route from Dawson Creek, B.C. to Whitehorse on the Alaska Highway had been opened. This pioneer road was completed in November 1942 and converted into an all-weather military highway by October 1943.

As the transportation systems came into operation crews started from Whitehorse and Norman Wells to construct the Canol access road at both ends. This road was completed in December 31. 1943 and in the following February (1944) the first weld was made in the 595-mile pipeline. On April 30, 1944 the official opening of the refinery was fittingly commemorated.

Many hardships were endured during the early 1900's in the North. The following is a story of just one instance depicting the trials and tribulations of travelling from Skagway to Whitehorse during the winter.

The Snow Blockade

The photograph of the steamer Cutch as it was taken a year ago on one of her stormy voyages from the Sound, was brought to the minds of the people of White Horse today when the train arrived from Skagway after six long days battle in the snow and ice and the entire train looked like some of the old time pictures of Santa Claus' Christmas time excursions. A dozen bewhiskered and hungry passengers came through from Skagway and barber shops, bathrooms and restaurants did a thriving business for several hours after the train pulled into the depot.

The train left Skagway last Thursday morning in charge of Conductor Connelly, with McGee as engineer. The big rotary plow with two engines started ahead and moved along with little or no trouble until the summit was reached where the difficulties commenced. It was stopping, digging out and starting until late Thursday evening when. about one and a half miles this side of Fraser, two drawheads were pulled out of the plow engines and they were compelled to lay up for the night. Some of the passengers mushed up to Log Cabin, a distance of three miles, and waited there until Sunday when the train came along again with the broken drawbars replaced, they having been brought from Skagway by the second rotary.

Bennett was reached Sunday evening and

there was another delay of two days, first as a result of one of the rotarys leaving the track over a broken rail and then one of the engines became disabled. The small rotary started ahead of the train from Bennett and was only enabled to run five miles when she had to be backed up again to Bennett for another tank full of water. Pennington was reached at midnight last night, where the train which left here Thursday for the south was passed and the big rotary started below ahead of her. The smaller rotary came as far as Caribou ahead of Connelly and from the latter point the track was found to be comparatively clear.

At Pennington it was learned that there had been several big snow slides between the Summit and Glacier and there is a chance that the line through to Skagway may continue to be blockaded until the weather moderates.

Among the passengers on the train arriving today was Post Offic. Inspector James, U.S. Customs Agent Idlemane bound for Forty Mile, James Larkin who is to have one watch in the prescription department of the Windsor Bar, Dr. Nicholson and half a dozen others who are enroute to Dawson. A.E. Chantler who had charge of the advertising for the annual edition of the Skagway Daily Alaskan, and who is now with the Alaska Yukon Advertising Co., was also one of the passengers on the belated train.

Work To Be Resumed

On The Anaconda, Rabbit Foot and White Horse Group Mines For Which Large Sums Have Been Offered and Refused

The excellent returns from Messrs. Graingers & McIntyre's properties has given a fresh impetus to copper mining in the White Horse district, and in the course of the next two or three weeks a force of men will be put to work on the Anaconda mine, which has already had sufficient development done to prove it equally rich as the Copper King.

The group of mines comprising the Anaconda, Rabbit Foot and White Horse, is owned by Messrs. J.P. Whitney, A. P. Benton, Ole Dickson, W.A. Pucket, Charley Ward and O'Neil. Of these the Anaconda is the furthest advanced in development, 135 feet of tunnel having already been run, besides numerous cross-cuts and several shafts to a depth of 20 feet.

Last June \$100,000 was offered and refused for the Anaconda and five weeks ago an offer of \$150,000 for the Anaconda and Rabbit Foot was also declined.

The lode on which these claims are located shows an average width of 75 feet, and assays from picked ore have given values as high as \$258 per ton.

At the Anaconda there are now about 100 tons of ore on the dump, but the owners have decided not to ship any of it at present, and will wait for the erection of a smelter close at hand which has every indication of being an accomplished fact during the coming summer.
